# Case Description: John W. — Airline Pilots Interpretive Report

This case illustrates the test-retest procedure used by Dr. James N. Butcher, author of the Minnesota Report<sup> $\mathbb{M}$ </sup>: Revised Personnel System—3rd Edition, for reducing test defensiveness.

Job applicants often present themselves in a very favorable light, minimizing problems and asserting good psychological adjustment. If they are administered a psychological test as part of the application process and respond defensively to the items, the results may be invalid. However, research has shown that people tend to be less defensive in their responses to the MMPI-2 if they are warned that the test includes measures to detect defensiveness and faking. When people are encouraged to respond honestly to avoid invalidating the test, they tend to respond more openly. Instructions such as the following are usually effective.

"When taking psychological tests, some people try to create an overly positive or overly negative impression of themselves. As a result, their test results may not be usable. The MMPI-2 includes several measures to evaluate whether people responded truthfully to the items. To ensure that your results will provide accurate information about you, please respond honestly to the items and try not to leave any of them blank."

Following is an example of a test-retest assessment with the MMPI-2. After the first administration produced invalid results, the test was administered again with instructions similar to those above. The second administration produced more usable personality information than the first.

The applicant, John W., is a 44-year-old pilot who is a captain with a regional commuter airline. He graduated from a four-year aviation college with a degree in aviation science. He started flying for the regional carrier three years ago following his discharge from the Marine Corps. He spent 20 years in the service, where he flew helicopters and fixed- wing jet aircraft. He was discharged from the military with the rank of major. The background investigation disclosed three driving offenses in the past 10 years and no other arrests.

Case descriptions do not accompany MMPI-2 reports, but are provided here as background information. The following report was generated from Q-global<sup>™</sup>, Pearson's web-based scoring and reporting application, using Mr. W.'s responses to the MMPI-2. 



#### MMPI-2 CLINICAL AND SUPPLEMENTARY SCALES PROFILE





#### PROFILE VALIDITY

This is a valid MMPI-2 profile, but the applicant may have attempted to present an unrealistically favorable picture of his virtue and moral values. As many job applicants do, he apparently felt the need to present an image of strong moral character and to deny human frailties.

His approach to the MMPI-2 items, however, suggests a rather naive or unsophisticated self-image. His MMPI-2 profile is probably an underestimate of his adjustment problems.

## PERSONAL ADJUSTMENT

This applicant's normal-range MMPI-2 clinical scale profile suggests that he views himself as having few psychological problems. Although generally shyer than other applicants, he did not report any psychological conflicts or stresses that are creating problems for him at this time. Individuals with this profile believe that they are able to manage their lives well and generally show resiliency in dealing with problems when they occur.

He seems to lack the broad cultural interests that are characteristic of many individuals with his level of education. He appears to have a rather limited range of interests and prefers traditional, action-oriented activities to artistic and literary pursuits or introspective experiences. He may be somewhat intolerant and insensitive, and others may view him as rather crude, coarse, and narrow-minded.

In addition, the following description is suggested by the content of this applicant's responses. He considers himself to be in good health and does not complain of somatic problems.

#### INTERPERSONAL RELATIONS

He appears to be somewhat shy and may have some social concerns and inhibitions. He tends to be a bit sensitive about others' judgments of him. He appears to be somewhat overcontrolled and submissive in personal relationships and in broader social situations, and he may have some trouble expressing his feelings.

The content of this applicant's MMPI-2 responses suggests the following additional information concerning his interpersonal relations. He reports that his home life was positive, pleasant, and problem-free. He indicates that he feels strong emotional support from those close to him. He views his home life as pleasant and supportive. He does not view himself as being too competitive or aggressive toward others.

# **PROFILE FREQUENCY**

His MMPI-2 clinical scale scores are elevated at or below a T score of 59. Profiles with all of the clinical scales below a T score of 59 occurred in 22.5% of the normative sample of men. However, 37.33% of one sample of male airline pilot applicants (Butcher, 1994) and 39.06% of another sample of male pilot applicants (Pearson Assessments Archival Data, 1994) had clinical scale scores in this range.

#### CONTEMPORARY PERSONNEL BASE RATE INFORMATION

No contemporary personnel base rate information is provided for normal-range clinical profiles like this one.

#### PROFILE STABILITY

No profile stability information is provided for normal-range clinical profiles like this one.

#### POSSIBLE EMPLOYMENT PROBLEMS

This normal-range personality pattern suggests very few likely employment problems. He would probably have little trouble adapting to a wide range of work environments.

#### CONTENT THEMES

MMPI-2 content themes may serve as a source of hypotheses for further investigation. These content themes summarize similar item responses that appear with greater frequency with this applicant than with most people.

His interpersonal behavior may be influenced by the fact that he keeps problems to himself a great deal.

He may be overly sensitive in interpersonal relationships.

He may have problems with passivity and low assertiveness with more dominant people.

He may be uncomfortable in social situations.

He may have low energy or lack enthusiasm.

He may be unusually sensitive to criticism.
