The emotional and behavioral needs of today's youth continue to evolve and require assessment tools that reflect current research and support high-stakes educational decision-making. This session examines key enhancements in the BASC-4, including updated norms, new narrowband Mood Disorder, ASD (autism spectrum disorder), and ADHD (attention-deficit/hyperactivity disorder) Scales, and expanded content scales designed to capture contemporary student profiles accurately and comprehensively. Participants will learn how BASC-4 composite and scale scores, clinical indexes, and Emotional Disturbance Qualification Scales (EDQs) can be applied to differential diagnosis and IDEA eligibility determinations, with a focus on ED, while continuing to provide evidence-based links to interventions that work.
